Annual Meeting Review

The annual opportunity for voting-members and supporters of Madison Meadow to get an update on Meadow business took place February 28th at Tsunami Books. Our amiable greeters were the friendly and capable hostesses **Ellie Parish-Mueller** (left) and **Eva Happy** (right), below.



After a financial report and a review of 2007 Meadow activities, board members and voting members up for new terms were elected. The Board of Directors elected for the next year are: Lora Byxbe; Craig Haines; Susan Jerde; Lynne Marsh; Linda Prier; Sandra Quigley; Debbie Summers; and Doug Yook. The full voting membership currently numbers 40.

Clarifying changes to the bylaws were then adopted, improving the language on selecting and retiring voting members, and eliminating redundant language from the creation of the corporation.

Next, Linda Prier led a group visioning for the future of the Meadow. Some of the ideas offered by voting members were:

- Incorporate a grove of madrone trees

- Take out the dead walnut tree and use the wood to make benches
- Put in an information kiosk
- Incorporate a bag dispenser for dog waste
- Tree plantings on the east and west side of the Meadow
- Add elderberry bushes
- Add a sanctuary corner and a children's corner
- Put together a long range 5-year and 10-year plan for the Meadow
- Encourage the use of the Meadow for education for both children and adults
- Invite studies of the natural world such as bird counts and storm water studies to take place

Who is Madison Meadow?



Last Child in the Woods



Many neighbors have read the book Last Child in the Woods, by Richard Louv. It is an inspirational work, related to what Madison Meadow is all about. The following commentary on the book was found online:

“As children’s connections to nature diminish and the social, psychological, and spiritual implications become apparent, new research shows that nature can offer powerful therapy for such maladies as depression, obesity, and attention deficit disorder. Environment-based education dramatically improves standardized test scores and grade-point averages and develops skills in problem solving, critical thinking, and decision making. Anecdotal evidence strongly suggests that childhood experiences in nature stimulate creativity.

In Last Child in the Woods, Louv talks with parents, children, teachers, scientists, religious leaders, child-development researchers, and environmentalists who recognize the threat and offer solutions. Louv shows us an alternative future, one in which parents help their kids experience the natural world more deeply — and find the joy of family connectedness in the process.”
